### FLORIDA APPEALS

### **OVERVIEW**

Florida's Rules of Court designate the types of appeals that are permitted.

- Appeal to Circuit Court: County Court cases misdemeanors, county civil and traffic infraction cases.
- Appeal to District Court of Appeal or Florida Supreme Court: Circuit Court cases felonies, circuit civil, probate and juvenile cases.
- Appeal the Florida Supreme Court: Death penalty cases are appealed directly from the Circuit Court to the Florida Supreme Court by law.

In almost all cases, the appellate court only looks at two things:

- Whether a legal mistake was made in the trial court.
- Whether this mistake changed the final decision (called the "judgment") in the case.

The <u>FLORIDA COURTS JURISDICTION</u> chart below is from the Office of The State Courts Administrator's website: (<u>www.flcourts.gov</u>) It may help to determine which court has jurisdiction in your Appeal.

The Office of the State Courts Administrator (OSCA) was created in 1972 to serve the chief justice in carrying out his or her responsibilities as the chief administrative officer of the judicial branch, which includes the Florida Supreme Court, six district courts of appeal, 20 circuit courts & 67 county courts. OSCA also prepares the branch's budget requests, collects, and analyzes court-related data, certifies and trains mediators and court interpreters, and coordinates education programs and publications for judges and court employees.

This chart is a general guide to the jurisdiction of courts in Florida. The bullets on the left side of the chart specify matters within the primary jurisdiction of the court and the bullets on the right side specify appeals for which the Florida Supreme Court and Florida District Courts of Appeal have discretionary jurisdiction.

This chart is not intended to be comprehensive; many exceptions and distinctions exist.
