## MARCHMAN ACT – BAKER ACT

### **OVERVIEW**

**Marchman Act** – Florida's Substance Abuse Impairment Act provides assistance to individuals in need of emergency services and temporary detention due to substance abuse.

**Baker Act** – is a means of providing individuals with emergency services and temporary detention for mental health evaluation and treatment when required (often referred to as an Ex Parte Order).
